





- Encourage key suppliers to join CAC to promote and expand a transparent business network without monopoly and bribery.














Responsible Recruitment and Employment





<u>Objective</u>: Introduce and embed responsible recruitment and employment practices throughout the seafood supply chain in Thailand.

<u>Progress</u>: Seafresh and ISSARA work together in Myanmar to ensure a fair recruitment process and raise awareness about labor rights. Moreover, The Issara Institute surveys our supply chain and provide workers with an independent grievance mechanism. We help raising awareness and compliance with the Seafood Task Force's Code of Conduct in collaboration with the Federation of Thai Shrimp Farmers.

<u>Next 12 months</u>: Map labor recruitment supply chain by vessels, plants and farms. Pilot targeted fleet owner and plant operator recruitment options. Build accredited recruitment agency list used by Task Force Membership. Formulate guidance on the no-fee implementation for Members.
















Thai Shrimp Supply Chain Development

The company has a team responsible for Supply Chain Development. We provide advice to the suppliers in production process development for the quality material, environmentally friendly practices and to treat workers fairly. They also monitor the operation continuously. To ensure that the company has a social responsibility throughout the supply chain. The main topics are following:

- Shrimp farms must be located on land with title deed and no forest encroachment.
- To have treatment ponds before discharging water to the environment.
- To treat workers fairly.
- To use environmentally friendly methods and efficient waste management.
- To control impacts on the surrounding ecosystem.
- To have an efficient document management system for traceability.















Supplier Development

We continuously develop our suppliers which are shrimp farm including packaging and ingredient manufacturer to achieve the standard certification such as ISO9001, BRC, HACCP and GMP. Moreover we have the team monitored the operation of suppliers that treat workers fairly, and protect the environment or not. If any suppliers do not comply the condition, the company will not buy the products from them.
